

## BALI WEDDING GIVEAWAY TERMS & CONDITIONS

1. Promotion Period. The Ultimate Bestie Giveaway (the "Promotion") will begin at 7:00:00 pm. Australian Eastern Daylight Time ("AEDT") on 17th January 2023 and will end at 11:59:59 p.m. AEDT on 7th February, 2023 (the "Promotion Period"). The Bali Bride ("Leisa Brenchley" or "Sponsor") computer is the official timekeeping device for the Promotion.

By participating in the Promotion, entrants represent that they have reviewed, accepted and agreed to be bound by the Official Rules, and accept the decisions of the Sponsor as final and binding in all respects. Winning a prize is contingent upon entrant fulfilling all requirements set forth in these Official Rules.

14. Governing Law / Jurisdiction. The Promotion is subject to all applicable, as the case may be, national, federal, territorial, state, and local laws of Australia, the United States of America and worldwide. To the extent permitted by law, entrants consent to the jurisdiction and venue of the courts located in New South Wales, Australia for the resolution of any disputes, claims and causes of action arising out of or relating to this Promotion or the prize (individually, "Claim"). All Claims shall be resolved individually, without resort to any form of class action. Any claims, judgments and/or awards shall be limited to actual out-of-pocket costs incurred, including without limitation costs incurred with entering this Promotion.
